SUBJECT

This User Notice is to inform users that the General Dental Council (GDC) interface will be operational within a month and to remind users to assign the Dental Professional registration role to appropriate individuals.

DETAIL AND ACTION REQUIRED

The GDC interface is expected to be operational within a month. Confirmation of the exact date will be provided in a further User Notice.

ESR leads are requested to take these two important steps in readiness for the implementation of the GDC interface:

1. Reminder to assign the 'Dental Professional Registration' role to appropriate individuals.

This role will work in a similar manner to the Medical Staffing Officer Role for GMC registration updates and the Nursing Professional registration role for NMC registration updates. When the interface is operational, individuals assigned to this role will receive notifications of successful updates, unsuccessful updates and decision notifications, in respect of GDC registrations. Refer to User Notice 2828 for full details.

To date, **only 59%** of relevant NHS organisations have assigned individuals to the Dental Professional Role.

Organisations that do not assign this role will not benefit fully from the GDC interface. It is therefore imperative that this role is assigned where appropriate.

2. Review the accuracy of GDC registration data entered in ESR

To assist NHS organisations with this essential step, a notification will be produced prior to go live of the interface that will inform the **Dental Professional registration role holder** of registration numbers that have an invalid format, have not been found or have been assigned incorrectly. The **Dental Professional Registration role holders** are requested to review the notification and to take appropriate action as soon as it is received. This data cleanse notification will be sent weekly, starting from Thursday 30th January 2020.
