## SUBJECT

To make NHS Organisations aware of the potential impact COVID-19 could have on the delivery on ESR output such as Payslips, P60's and P45's.

## DETAIL

Whilst the ESR Courier Company are currently able to deliver to ESR NHS Organisations, possible changes to Government guidance around COVID-19 and the potential impact upon employees of the courier company means that we may have to consider disruption to the delivery of paper outputs .

Also, with Organisations home working where possible, there may be no one at the site available to take delivery of the outputs and therefore the output would re-enter the Couriers network, and eventually be returned to the Printers.

## ACTION REQUIRED

Should you be working from an alternative address, please be mindful and either do not print the paper payslips, or ensure someone is on site to take the delivery. All payslips returned to the printers will be securely destroyed.

Organisations are asked to consider the impact of not receiving paper outputs from ESR and are asked to look at the option of enabling the ESR Online payslip functionality for all of their employees, which will provide access to Payslips and P60s.

Should a printed payslip be required, Organisations are able to run the NHS Copy Pay Advice process at payroll level, or by individual assignment, and print from the assocated PDF file created. Please note that no local messages will show on the Copy Pay Advice.

Users wishing to identify if employees are opted in or out of printing a payslip can do so by creating a BI report using the following subject area;

Subject Area: Human Resources – Person EIT Details Folder: EIT Print Payslip/P60

For P45's, due to real time reporting HMRC records will be up to date with leaver payment information. Employees may wish to consider registering for an HMRC Personal Tax account via
