To advise users of actions related to Flash based e-Learning content.

DETAIL

Adobe Flash Player is being removed at the end of this year, after this date, any web based content which uses Flash including e-Learning content will be blocked from running.

As a precaution, all content that currently uses Flash as the main medium will be populated with an end date of the 31st December 2020. Where the content is replaced before this date, then the end dates will be removed.

The end dates will be populated between the 17th and 31st December.

There are some courses that have Flash interactions, but contain alternative methods to view the content, for example a text version of a Flash video. These courses will not be end dated.
