### **SUBJECT**

As part of NHS Digital's NHS Mail migration, we have been informed that the ESR workflow mailboxes will be migrated on the 11<sup>th</sup> January 2021.

### **DETAIL**

The mailbox limits being introduced by this migration mean that changes are required within the ESR set-up to ensure that workflow emails continue to flow successfully between ESR and our users. In order to ensure that these ESR changes are in place before the 11<sup>th</sup> January 2021 we intend to make them on Saturday 9<sup>th</sup> January 2021 and this means that emails from ESR will be suspended between 7am and 12pm on Saturday morning.

We will publish a notification on the ESR Hub informing users of this suspension.

# **ACTION REQUIRED**

Whilst our discussion and due diligence have suggested that these changes will have no impact to our user organisation beyond the initial implementation, we would strongly suggest that you consider the following:

- As this will have no impact on the delivery of notifications, advise your managers and
  professional users in particular to check ESR directly for any new notifications requiring
  approval during the first week following the NHS Digital migration;
- Inform your users that ESR e-mails will be suspended on Saturday morning this is particularly relevant to any user who require the password reset function during this period'
- Add the following mailboxes to your "safe list":
