Organisations can consider setting vaccine specific competence requirements against existing positions and individual positions they have created to support the Vaccination Programme recruitment process.

Only those roles that need to undertake the vaccine-specific training should also be assigned the vaccine-specific competence requirement.

Competence changes are effective from 1st January 1951.
