Staff who have been trained by a Fit2Fit accredited trainer to carry out fit testing to NHS staff on FFP3 masks should be assigned the NHS|MAND|FFP3 Fit Tester| competency from the date when the training was completed.

FURTHER INFORMATION

It is recognised that organisations may have recorded fit testing data in different ways and on different systems to meet national reporting requirements and enable local monitoring. In order to assist the recording of fit testing data within ESR the ESR Central Team can support the initial bulk uploads of existing data via the mass update service.
