Learning resources for health professionals caring for children and young people with asthma

Professionals within your organisation who work with or care for children and young people with asthma can access training to improve their knowledge and help to care for children and young people with asthma in the best way possible.

The training is split into five tiers; the first tier targets a range of people working closely with children and young people; such as those based in schools and out of school clubs.

Tiers two, three, four and five have been designed for healthcare professionals.

NHS England has been working with a national working group for training and education and the training and capabilities are now hosted by Health Education England.

Currently the UK has some of the highest death rates in Europe for childhood asthma and outcomes are worse for those living in the most deprived areas. NHS England is committed to improving outcomes for children and has published the <u>National bundle of care for children and young people with asthma</u> to support asthma care.

This training provides a clear structure for both health and non-healthcare professionals to understand what knowledge they need.
