Tier 1 of The Oliver McGowan Mandatory Training on Learning Disability and Autism is for people who require general awareness of the support autistic people or people with a learning disability may need.

To gain this competence staff must have completed the e-Learning (000 The Oliver McGowan Mandatory Training on Learning Disability & Autism Part 1) AND have attended part 2, a 1-hour online interactive session co-delivered by a person with a learning disability and an autistic person along with a facilitator. It must be the official Oliver McGowan Mandatory Training delivered by approved trainers.

Tier 1 training covers all the Tier 1 capabilities of both the Core Capabilities Frameworks for supporting people who have a learning disability and autistic people.

Tier 2 of The Oliver McGowan Mandatory Training on Learning Disability and Autism is for people who may need to provide care and support for autistic people or people with a learning disability.

To gain this competence, staff must complete the e-Learning (000 The Oliver McGowan Mandatory Training on Learning Disability & Autism Part 1) AND have attended part 2, a 1-day face to face training session co-delivered by a person with a learning disability and an autistic person along with a facilitator. It must be the official Oliver McGowan Mandatory Training delivered by approved trainers.

Tier 2 training covers a careful selection of the learning outcomes from the Core Capabilities Frameworks' Tier 2 capabilities, in addition to all the Tier 1 capabilities.

Individuals only need to complete either Tier 1 or Tier 2, whichever is most appropriate to their role. Depending on their role, staff may require further capabilities in addition to those covered in the Tier 2 Oliver McGowan Mandatory Training on Learning Disability and Autism package.

It is the responsibility of employers to determine any further capabilities their staff need and to put in place the appropriate provisions.

Employers must continue to review the training needs of their staff and provide relevant training for each role.
