## SUBJECT

Expressions of interest to host regional face-to-face training.

## DETAIL

Further to UN3394 the ESR Education Team are pleased to re-open expressions of interest from Organisations to host regional face-to-face training.

Regional face-to-face Education was introduced based on a series of user workshops concluding that this would be the preferred option for those wanting to attend classroom training. This then reduces the requirement for users to undertake extensive travel by sharing the learning between groups of Organisations in the locality.

It did however become clear from our experience of scheduling the initial round of courses, which commenced in February 2024, that there was some misunderstanding around the role of the host Organisation.


For clarity, please see the below guidance. You **MUST** agree to meeting these requirements to be considered as a host Organisation.

## Host Organisation Responsibilities

When putting forward an expression of interest to act as a host Organisation for regional training you are agreeing to the following:

- You will act as a host for training across your region.
- You will be offered a proportion of the available capacity for internal attendees and will open the remaining allocation to external attendees from the region.
- You can provide a room for us to deliver the training which has a minimum capacity of 10 delegates, including the trainer. NOTE: The room does not have to provide training PCs as there is the option for delegates to use their own device.
- On confirmation that your Organisation is booked for regional training you will complete a declaration that commits your Organisation to acting as a host and this will be signed by an appropriate director (Finance, HR, Workforce).

It must be stressed that we **cannot** provide dedicated training to an individual Organisation.

During the courses we will use a training environment that requires access to the Health and Social Care Network (HSCN). Connectivity checks will be provided to the host, and individual attendees if using their own device, on confirmation of the events taking place.

We can offer the following courses on a regional basis:

- ESR Business Intelligence (ESR BI) – Creating BI Content – 1 day
- ESR Business Intelligence (ESR BI) – Customising National BI Content – 1 day
- Oracle Learning Management (OLM) – Creating Catalogue Content – 1 day
- Oracle Learning Management (OLM) – Enrolments and Subscriptions – 1 day

As the host for your region, we can offer you 2 consecutive days in your allocated month where we can provide any combination of the courses listed above.

There is a 6-week lead time to arrange the training therefore it is imperative you can meet the requirements set out in this notice before providing an expression of interest.

As courses will be scheduled on a first come, first served basis you must be committed to working with us to co-ordinate the training and be flexible in the dates you can accommodate.

You will initially be provided with the month we can deliver at your Organisation and be asked to provide the dates you have available in that period.

Failure to respond in a timely manner will result in your allocated month being offered to another Organisation and will require you to re-submit your interest to host.
