
2 New 'Immunisations and Checks' EIT - Covid-19




The only value available for selection in the Type field is 'SARS-CoV-2'.

3 New 'Renew' button for Learning Certifications

If an employee has competencies that have expired, are nearing expiry or have never been achieved, the Find Learning icon can be used to search for all learning events available that will award the competence on successful completion. This page can be reached via the following routes:

- Compliance and Competencies page
- Learner Homepage
- My Compliance Portlet Dashboard

A 'Renew' icon has been added to the Learning Certifications section of the 'Find Learning' search results page.



After clicking 'Find Learning':

If the employee is not yet subscribed to the learning certification the 'Details' icon will be enabled and the 'Renew' icon will be disabled. Clicking on the 'Details' icon will allow the employee to subscribe to the learning certification and enrol on the required classes.

If the employee is subscribed to a learning certification that is renewable but is not yet due for renewal then the 'Details' icon will be enabled. Clicking on this icon will allow users to view the details and courses associated to the certification within the certification period.

If the employee is subscribed to a learning certification that is due for renewal then the 'Details' icon will be disabled and the 'Renew' icon will be enabled. Clicking on the 'Renew' icon will renew the certification creating a new certification period. The user will then be directed to a page that will allow them to enrol onto any mandatory classes (if they are not already enrolled) and also any optional classes (if any have been included).

Known Issues

- PRB2001526 if a learner unsubscribes from a Learning Certification which has not passed its due
 date, they will be unable to unsubscribe using Find Learning. The user will receive the following error
 message when trying to re-subscribe: 'This certification is already renewed'. It is advised that
 Learning Administrators prevent learners from unsubscribing from Learning Certifications by setting
 the 'Prevent Unsubscribing' field to 'Yes'.
- PRB2001540 Where a user has become certified on a renewable learning certification that has
 restrictions in place based on e-Learning classes being available for enrolment and further courses
 are added to the certification that also include e-Learning classes then upon pressing the renew
 button the newly added courses will be displayed disregarding any restrictions that were originally in
 place. Organisations can add additional offerings to existing courses if they want the original
 restrictions to apply.

Problem Record to be raised - Where a learner is enrolled on the e-Learning option for a Learning Certification, on renewal, the classroom based options are not displayed where the learner has the

option to complete the Learning Certification via e-Learning or classroom.

4 <u>Date Place Booked - IAT</u>

The IAT process has been modified so that when delegate booking information is transferred the 'Date Booking Placed' will be recorded in the Registration Date field of the Add'l Delegate Booking Info. DFF for the enrolment.


This field can be reported on through BI and appears in the NHS Learning Administration dashboard.

5 <u>P11D 2019/20</u>

The following functional changes are made to cater to P11D 2019-20 legislative updates:

- 1. All Working Sheets have been modified to reflect the new Tax Year 2019-20.
- 2. For 2019-20, the Number of Days in the Year is changed to 366 as 2020 is a leap year.
- 3. Multiplier used in calculating the fuel benefit has increased from £23,400 to 24,100, whereas the basic calculation method remains unchanged.
- 4. Multiplier used in calculating the van fuel benefit has increased from £633 to £655, whereas the basic calculation method remains unchanged.
- 5. The cash equivalent value used to calculate the benefit for a van which is available for private use has increased from £3,350 to £3,430.
- 6. The official rate of interest is retained at 2.50%.
- 7. The Relevant Threshold is the value which forms the basis of the appropriate percentage from 2012/13 onwards. For 2019/20, it is set at 95 g/km.
- 8. In addition, special rules cover cars where the unrounded CO2 emissions figure does not exceed 75.
- HMRC has published tables to select the appropriate percentage for using in the car benefit calculation, based on CO2 emissions.
- 10. A new 'Valid Benefit Start Date' field has been added to Car and Car Fuel 2003_04 element within the Further Entry Information entry value and should be used to indicate if 06-Apr-YYYY is the actual date of car availability:



A date of 06-Apr-YYYY is reported in the 'From' field in the 'Dates car was available' section F Cars and Car fuel, of P11D Expenses and benefits 2019 to 2020, and only when the Valid Benefit Start Date is set

To Yes. Otherwise the field will be blank. The same rules are in place for AvailFrom field in the XML version of P11D.

- 11. Fuel Types accepted by HMRC are A, D, and F. The 9 different Fuel Types are reported under the Fuel Types A, D and F (from April 2019):
 - Fuel Type B, C, G, H, P and E will be reported as Fuel Type A.
 - Type L & D will be reported as Fuel Type D.
 - Type F will be reported as Fuel Type F.
- 12. The format of the P11D and accompanying worksheets has been updated in line with the specification for 2019-20. The XML file produced is also updated to comply with the 2019-20 specification issued by HMRC.

PLEASE NOTE: If the Payrolled Benefits (NR) NHS element is used then the Class 1A NIC will have to be manually calculated. If you are also processing P11D's then the P11D(b) can be submitted via ESR. This should be the total Class 1A NIC liability for the both payrolled and non-payrolled benefits. If you are only payrolling benefits in kind then the P11D(b) must be submitted online with HMRC.

6 Scottish Rates of Tax 2020/21

The 2020-21 Scottish income tax bandwidths and percentages effective from 6 April 2020 are as follows:

The rates used in the calculation of SRIT for 2020-21 are different to those used in the calculation of PAYE for the rest of the UK.

Rate	Percentage	Band
Starter Rate	19%	0 to 2084
Basic Rate	20%	2,085 to 12,657
Intermediate Rate	21%	12,658 to 30,930
Higher Rate	41%	30,931 to 150,000
Additional Higher Rate	46%	Over 150,000

The basic personal allowance is increased, and is same as that for rUK, which is £12,500.

Please note that although the rates of Tax have not changed the bandwidths have.

The revised bandwidths come into effect from payrolls where the payment date is on or after 11-MAY-2020 but are applicable from 06-APR-2020.

Employees on a WK1 / Month1 will not be backdated.

7 <u>Covid-19 Sickness - Enhancements</u>

The AFC Average Pay NHS element will have the restriction removed to calculate average pay during sickness for any AFC staff earning above the £18,160 threshold. This will apply to sickness that has the COVID-19 reason recorded in the Related Reason field only.

PLEASE NOTE: it is still a manual process to ensure that staff do not go into Half or Nil Pay as a result of Covid-19 related sickness. The Entitlement can be amended as required in the OSP form to ensure that the sickness remains in Full Pay as per the guidance provided in UN2888.

This change will also affect any recurring enhancements that would normally reduce on sickness. If the sickness absence has the Covid-19 Related Reason recorded then these enhancements will continue to be paid as if the person had not been sick.

Users should note that where they have 'Covid-19' absences which have already been processed, then they will need to run NHS Retro Pay by Element with an assignment set created for the affected employees.
