# 1 **Introduction**

The purpose of this document is to provide details of the enhancements to the ESR system in Release 50.3.0.0. The details are grouped in functionality order.

**The changes to functionality outlined in this Release Notice are subject to successful testing. As is normal practice, any amendments to the content of the Release will be communicated in the Final Guide to Enhancement Notice.**

**NOTE:** All Employee data used in this publication is fictional. Any similarity with the names used in this publication with the names of actual persons is purely coincidental and not intentional.

## 2 **New and Replacement Values for the COVID-19 Vaccinations EIT**

Two replacement values have been added to the 'Vaccination 1/2 Product' fields in the 'COVID-19 Vaccinations EIT' as follows:

The reports listed below have also been updated to reflect the new and replaced values:

Information entered in the COVID-19 Vaccinations EIT that is displayed in this report will be prefixed with 'CVV'.

- NHS OH Individual Employee Summary Report

The information related to COVID-19 Vaccinations can be found under the 'Immunisation Information' section.

- NHS OH Staff List by Individual Test or Immunisation

The values 'COVID-19 Vaccination 1' and 'COVID-19 Vaccination 2' need to be selected from the 'Test or Immunisation Name' list of values. These values will enable the reporting of information entered on the COVID-19 Vaccinations EIT.

**IAT**

The Pre-IAT FYI Notification and Post-IAT FYI OH Notification include the new and replacement values.

**Portal**

The Immunisation and Checks PDF which is available from the My Personal Information and My Applicant Details portlets includes the new and replacement values.

### **3 General Pharmaceutical Council (GPhC) Registration Number Validation**

To accommodate the recording of temporary registrants being employed in response to COVID-19, the validation of the GPhC registration number has been relaxed and any combination of alphanumeric characters is now allowed.

## 4 **ESRBI Reporting on Professional Registration Body Information**

ESRBI users can now report on all Professional Registration Body Summary EIT information in a single analysis.

This can be done by selecting items from the new folder 'EIT Regs and Memships – All' which can be found under the Subject Areas 'Human Resources - Person EIT Details' and 'Human Resources - Applicant EIT Details'.

The new folder has the same permissions as the existing folders in the subject area and will also work with the existing 'facts'.



## 5 NHS Monthly Summary for Pension Schemes Report Update

The NHS Monthly Summary for Pension Schemes report now includes the contributions from the Pension ERRBO NHS element. The employee contributions and the employer contributions will be reported separately and also included in the summary as part of the NHS Pensions section.
