2 Change to File Name for Payslip and P60 Downloads

The default name for the ePayslip available for download from the ESR Portal is now

ePayslip yyyy-mm-dd Assignment Number (where the date is the pay date from the payslip).

For example, ePayslip 2022-05-31 20066648.pdf

3 Updates to Competency Expiry and Competence Requirements Change Notifications and Emails

The wording on the Employee Competence Expiry Notifications/Emails and the Competence Requirements Change Notifications/Emails has been updated to direct the learner to the My Compliance Portlet.

The wording for the Competence Expiry 1 Month and Short Notice notifications has been changed where the learner is already enrolled onto learning which will award the competence. No changes have been made to the other versions of these notifications.


