2 <u>Update to the Employee Self Service Conflict of Interest</u> <u>Declaration Wording</u>

The wording for the checkbox on the employee Declare a Conflict of Interest form has changed from:

I give my consent for this information to be published on registers that my Organisation holds.

to:

Declarations will be published unless there are exceptional circumstances as to why they should not be.

If you feel this is the case you will need to untick the box. If you do this you will be contacted to establish if you have reasonable grounds for your declaration to be excluded on registers that the Organisation holds.

The information submitted will be held by your Organisation for personnel or other reasons specified on this form and to comply with the organisation's policies. This information may be held in both manual and electronic form in accordance with the Data Protection Act 2018. Information may be disclosed to third parties in accordance with the Freedom of Information Act 2000 and published in registers that your Organisation holds.

3 Unpaid Absence Payslip Message

To assist in notifying employees when a deduction has been made from pay in relation to Industrial Action, a new payslip message has been created. This will be output when an employee takes an absence with either of the following absence types:

- Unpaid Unauthorised Special
- Unpaid Unauth Special Hrs

and the absence reason is Industrial Action.


Where two separate absences are added within the same period then two messages will appear, one for each occurrence with the number of day(s)/hour(s) stated for each occurrence.

The message will display as follows:

mesg = 'PYS: Pay reduced by x day(s) due to Industrial Action from Date A to Date B

mesg = 'PYS: Pay reduced by x hour(s) due to Industrial Action from Date A to Date B

where x is the number of days or hours for that occurrence and Date A and Date B are the respective start and end dates of the absence.
