2 Pregnancy Loss Absence Reason

A new Absence Reason of 'Pregnancy Loss' is now available to Users for the following Absence Types:

- Special Decreasing Balance
- Special Increasing Balance

The implementation of this new value supports the launch of the national Pregnancy and Baby Loss policy and will allow individuals to accurately reflect the reason for their absence in these circumstances. Additionally, the recording of this more granular information will enable local and national monitoring to help evidence the effectiveness and impact of the policy.

- Locally Agreed Grp 3 NR NP NHS
- Locally Agreed Grp 3 NP CALC NHS
- Locally Agreed Grp 3 NP PAY NHS
- Locally Agreed Grp 3 NP PAY NHS ARS

These have all been added with an effective date of 1-Mar-2025.
