For info	<p><b>Exporting Analyses from ESR BI</b></p> <p>When exporting reports into Excel format, the prompt to download the report was not always displayed even after ESRBI stated a successful export. In some circumstances, graph views were also not displayed when running an analysis.</p> <p>A solution for this issue is scheduled to be deployed during this release weekend. Users may experience a short interruption to accessing the ESR service between 08:00 and 12:00 on Saturday 28<sup>th</sup> November. Where users experience any interruption during this time, we advise users to attempt to login again which should proceed without issue.</p>
