This has now been fixed and where the pay date falls after 6th April, then this will be correctly considered as the new tax year and the payroll will not fail for week 1 in this case.</p> <p>Furthermore, in cases of termination, where an adjustment was due for the previous tax year, then the BIK adjustment element would erroneously be added to week 1 where the whole of week 1 dates fell prior to 6th April. This will no longer be the case and any adjustment to a previous tax year will not be done in the new tax year.</p> <p>It should be noted that the elements should be added and ended in accordance with the tax year. Therefore, for weekly paid employees the element should be end dated on the last working day of the last week, and then added on the first working day of week 1.</p> <p>For example where the following is the case: Week 1 29-Mar-21 to 04-Apr-2021 with a Payment Date 08-Apr-21 then the previous year's element should be end dated on 28-Mar-21, and the new one would be added on the 29-Mar-21.</p>	Pay \ RTI \ FPS
